Dear Friends and Neighbours (RAGED Residents),

This is the BIG one. Planning Appeal: APP/E5330/W/15/3129768, is because the Developer wants to overturn the Rejection of Planning Application 14/3551/F, from Linden and Novalong, to build on the GAA Site. This has to be **back with the Planning Inspector in Bristol by 13th October 2015.**

We are delivering a Pro Forma Letter you can use. They can be copied and one filled in by each person then sent in the same envelope. We will also gather them back and combine them all in our parcel if you return them to us.

Planning Appeal APP/E5330/W/15/3129768 on Planning Applications Ref:- 14/3551/F – GAA Sports Ground, Avery Hill Road – 135 Dwellings with Parking.

Our Residents are asking for 3 things:

- 1. This Leaflet explaining what to do to fight the Planning Appeal.**
- 2. Pro Forma Letters, with addresses, to send in their request for rejection. (Can be photocopied).**
- 3. A visit from our Street Reps so they can explain what is happening and get a Petition signed.**

Advice:- The greatest weight is given to individual hard copy Letters. You can add your own comments. The next strongest is email Letters and the Planning Inspector Website. Do both and send all Hard Copy Letters in one envelope? You need to give a name, address, date and **SIGN IT**. Remember you have to send in Requests to the Inspector this time. You can copy and send several Letters from each house or from remote addresses. **Get your Friends and Family to do them as well they all count.** Please also sign our Online Petition. Don't leave it to others to Request Rejection as they may think you are sending. We may supply further details but this is your one chance to kill the Planning Application at Appeal. If we fail now Greenwich Borough Football Club won't be coming to the Site and we will have a 3 story Housing Estate with Huge Local Impact very soon.
